
TEMPORARY CONSTRUCTION EASEMENT

THIS TEMPORARY CONSTRUCTION EASEMENT, executed and delivered to the Board of County Commissioners of Sedgwick County, Kansas (hereinafter, "County") by JEFF L. AND CHRISTINE GRIFFITH, HUSBAND AND WIFE, SCOT E. GRIFFITH, A SINGLE PERSON, AND THE ROBERTSON 2013 REVOCABLE TRUST DATED 24 MAY

WITNESSETH:



That for and in consideration of the sum of <u>THREE-THOUSAND DOLLARS AND NO/100</u> (\$3,000.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, Owner hereby grants, bargains, sells and conveys to County a temporary easement in, over, across and upon the following-described premises, to wit:

A tract of land in the Southeast Quarter of Section21, Township 29 South, Range 2 East of the 6th P.M., Sedgwick County, Kansas described as follows:

Commencing at the Southwest Corner of said Southeast Quarter; thence East along the South line of said Southeast Quarter a distance of 1248.59 feet to the point of beginning; thence North perpendicular to the South line of said Southeast Quarter a distance of 40 feet; thence East parallel to the South line of said Southeast Quarter a distance of 135 feet; thence South perpendicular to the South line of said Southeast Quarter a distance of 40 feet to the South line of said Southeast Quarter; thence West along the South line of said Southeast Quarter a distance of 135 feet to the point of beginning. Said tract contains 0.17 acres, more or less, excluding existing road right-of-way.

For the purpose of permitting all construction uses according to plans and specifications now on file in the office of the Sedgwick County Engineer. Said easement shall expire upon completion of the above described construction.
