**A RESOLUTION NOMINATING AND RE-NOMINATING RON RYAN, DAVID
ESLINGER, TIM BONNELL AND JOHN HENNESSY, JR.,
TO THE WICHITA AIRPORT ADVISORY BOARD**

WHEREAS, Kansas Statute K.S.A. 3-163, Charter Ordinance No. 178 and Ordinance No. 44-436; and Section 2.12.1054 of the Code of the City of Wichita, Kansas, established and provides that the Board of County Commissioners may nominate five (5) members for appointment to the Wichita Airport Advisory Board;

WHEREAS, each member nominated shall reside in a different County Commissioner's district. The membership term is two (2) years except that in the event the Commissioner making the recommendation for the nomination herein leaves office for any reason, said term shall expire and the member shall then serve until a successor has been duly appointed. If term has not expired, a successor shall fill the remainder of the unexpired term; and

WHEREAS, the following individuals are recommended for nomination or re-nomination to the Wichita Airport Advisory Board: Commissioner David Unruh is recommending Ron Ryan; Commissioner Jim Howell is recommending David Eslinger; Commissioner David Dennis is recommending Tim Bonnell; and Commissioner Michael O'Donnell is recommending John Hennessey, Jr., each for a two year term.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:


