**A RESOLUTION APPOINTING JOSHUA BLICK  
TO THE METROPOLITAN AREA PLANNING COMMISSION**

**WHEREAS**, pursuant to the interlocal agreement between the City of Wichita and the Board of County Commissioners of Sedgwick County, Kansas, Sedgwick County Resolution No. 127-2016 and City of Wichita Ordinance No. 50-316, dated November 17, 2016, and by Sedgwick County Code § 21-26, that the Board of Sedgwick County Commissioners shall appoint seven (7) members to the Metropolitan Area Planning Commission (MAPC);

**WHEREAS**, a vacancy exists due to the resignation of Art Gentry, who had been Commissioner Michael O'Donnell's previous appointee;

**WHEREAS**, Art Gentry's appointment expires on August 31, 2017;

**WHEREAS**, for any vacancy on this Board, the newly appointed member shall serve the unexpired term of the original appointment; and

**WHEREAS**, it is the recommendation of Commissioner Michael O'Donnell that Joshua Blick be appointed to the Wichita/Sedgwick County Metropolitan Area Planning Commission for the unexpired term ending August 31, 2017.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

Joshua Blick is hereby appointed to the Wichita/Sedgwick County Metropolitan Area Planning Commission to fulfill the remaining term that shall expire on August 31, 2017, except that in the event the Commissioner making the recommendation for the appointment herein leaves office for any reason, said term shall expire and the member shall then serve until a successor has been duly appointed.
