**RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A PEDESTRIAN CROSSWALK SIGNAL ON MACARTHUR ROAD APPROXIMATELY 650 FEET WEST OF OLIVER ROAD IN SEDGWICK COUNTY, KANSAS, AND PROVIDING FOR THE INSTALLATION, OPERATION, MAINTENANCE AND ENFORCEMENT THEREOF.**

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, pursuant to K.S.A. 8-2001 et. seq., has the power and authority with respect to streets and highways under their jurisdiction and within the reasonable exercise of the police power to enact and enforce resolutions regulating traffic, said resolutions relating to those subjects enumerated in L. 1996, ch. 15; and

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, determines that a pedestrian crosswalk signal is required on MacArthur Road approximately 650 feet west of Oliver Road.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:

SECTION ONE: A pedestrian crosswalk signal is established on MacArthur Road approximately 650 feet west of Oliver Road.

SECTION TWO: The pedestrian crosswalk signal shall operate at all times.

SECTION THREE: The pedestrian crosswalk signal shall be a High-Intensity Activated Crosswalk signal which it is commonly referred to as a HAWK signal.

SECTION FOUR: Sedgwick County Public Works shall install, operate and maintain the pedestrian crosswalk signal.

SECTION FIVE: All law enforcement officers with the jurisdiction in Sedgwick County, Kansas, are hereby authorized to enforce appropriate statutes as they pertain to pedestrian activity in public rights-of-way at this pedestrian crosswalk signal.

SECTION SIX: Any person who shall violate the pedestrian crosswalk signal established in this resolution shall be guilty of a misdemeanor as provided by law.


