**A RESOLUTION RE-APPOINTING FRANK RASH, RON LOVE, JOE SAMIA, AND  
ROGER LOWENSTEIN TO THE SEDGWICK COUNTY AND CITY OF WICHITA  
JOINT BOARD OF APPEALS FOR MECHANICAL CODE**

WHEREAS, the Board of County Commissioners adopted Resolution No. 135-2012 on August 29, 2012, and the City of Wichita adopted City Ordinance No. 49-333 on August 21, 2012, agreeing to consolidate the Board of Appeals for Mechanical Code more specifically designated as the Board of Appeals of Air Conditioning, Refrigeration and Warm Air Heating ("Joint Board");

WHEREAS, the Board of County Commissioners adopted the Wichita-Sedgwick County Unified Building and Trade Code ("UBTC") on November 21, 2012, and the City of Wichita adopted the UBTC on December 4, 2012;

WHEREAS, Article 1, Section 5 of the Unified Code provides for the terms of appointments to said Joint Board;

WHEREAS, Article 5, Section A of the Unified Code authorizes said Joint Board and the qualifications for members of same; and

WHEREAS, it is the desire of the Board of County Commissioners that the following members be re-appointed, as indicated below, to the Joint Board and that the terms of said members shall be two years from the effective date of appointment.
