## I. POLICY STATEMENT

The Purchasing Director shall be the custodian of the Kansas Titles and vehicle registrations of all County owned vehicles. Kansas Titles and current vehicle registrations of all County owned vehicles will be filed and maintained in the Purchasing Department. A list of all County owned vehicles will be maintained in the Purchasing Department detailing vehicle number assigned by the Central Motor Pool, i.d. number of the vehicle assigned by the manufacturer, and license tag number.

Departments assigned County owned vehicles shall be responsible for all costs of titles, tags and decals for such vehicles.

## II. <u>DEFINITIONS</u>

License Tags – The metal plates issued by the State of Kansas every five years to be attached to a vehicle.

Decals – An adhesive backed device issued by the State of Kansas to be affixed to the License Tag on an annual basis for renewal.

Kansas Vehicle Title (Title) – Official document of ownership issued by the State of Kansas for each vehicle registered and tagged in the State.

Registration – A document issued by the State of Kansas each time new license tags or decals are issued.

### III. PROCEDURES

- A. Title and registration of new vehicles
  - 1. The department assigned the County vehicle shall submit a payment voucher for the purchase of license tag to the Purchasing Department.

- 2. The Purchasing Department shall purchase license tag and decal and obtain registration from the Auto Tag Department.
- 3. ---(text not legible in original document)-- appropriate State of Kansas agency to obtain Title.
- 4. The Purchasing Department shall forward the License Tag and a copy of the vehicle registration to the department assigned the vehicle. The assigned department shall maintain the copy of the vehicle registration in the vehicle at all times.
- 5. Upon receipt from the state, the Purchasing Department shall file and maintain the vehicle title.

# B. Tagging County vehicles

- 1. License tags of County vehicles must be renewed each year. Automobiles and motorcycles are tagged in October. All trucks are tagged in January.
- 2. The State of Kansas forwards vehicle registration for County owned vehicles in the appropriate month to the Purchasing Department.
- 3. The Purchasing Department shall advise assigned departments when license tags must be renewed.
- 4. Assigned Departments shall submit a Payment Voucher for the purchase of tags or decals to the Purchasing Department.
- 5. The Purchasing Department shall Purchase tags or decals and forward them to the Central Motor Pool
- 6. The Central Motor Pool shall attach tags to vehicles or affix decals to tags.

## B. Disposing County vehicles and vehicle titles

- 1. Upon trade-in or sale of a County vehicle, title of the vehicle shall be transferred to the new owner by the Purchasing Department.
- 2. If a vehicle is salvaged or wrecked, the Purchasing Department shall forward vehicle title to the appropriate State agency.
