FIRST ADDENDUM TO LIVE TELEVISION COVERAGE AND CLOSED CAPTIONING SERVICES AGREEMENT

by and between:

SEDGWICK COUNTY, KANSAS and KANSAS PUBLIC TELECOMMUNICATIONS SERVICE, INC.

This Addendum made and entered into this ____ day of _____, 2017, by and between Sedgwick County, Kansas ("County") and Kansas Public Telecommunications Service, Inc., a Kansas not-for-profit corporation ("Contractor" or "KPTS").

WITNESSETH:

WHEREAS, County desires to provide live television coverage and closed captioning services of regular County Commission meetings; and

WHEREAS, KPTS, a nonprofit public television broadcasting station operating in Wichita, Kansas, desires to provide live television coverage and closed captioning services of County Commission meetings for Sedgwick County; and

WHEREAS, the parties hereto entered into an Agreement for Live Television Coverage and Closed Captioning Services ("Original Agreement") on December 14, 2016; and

WHEREAS, the parties now desire to set forth additional services to be provided under that Original Agreement.

NOW, THEREFORE, in consideration of the mutual covenants, conditions and promises contained herein, the parties hereto agree as follows:

7. Additional Services. It is agreed between the parties hereto that KPTS shall provide informational services for County relating to Sedgwick County government and services, at rates to be agreed upon by the parties. The subject matter of such production shall be provided by Public Information Officer upon reasonable notice to KPTS. County shall assist and advise KPTS in the production, using County staff and resources when possible to keep production costs at a minimum.

In the event that County recesses to executive session before 11:00am during a regular meeting time, KPTS agrees to air pre-produced County videos during such recess. The airing of such videos is within the sole discretion of KPTS. County agrees to compensate KPTS \$25.00 per each executive session (not per video) during which pre-produced videos are aired.

All other terms and conditions of the Original Agreement are retained under this First Addendum to the Original Agreement and shall remain in full force and effect and govern the actions and obligations of the parties hereto unless specifically accepted or otherwise noted above.
