

**A RESOLUTION APPOINTING ERIC PURKEY TO THE SEDGWICK COUNTY AND CITY OF WICHITA METROPOLITAN AREA BUILDING AND CONSTRUCTION DEPARTMENT (MABCD) JOINT BOARD OF CODE STANDARDS AND APPEALS**

**WHEREAS**, the Sedgwick County Board of County Commissioners adopted Resolution No. 135-2012 on August 29, 2012 and the City of Wichita adopted City Ordinance No. 49-333 on August 21, 2012, agreeing to consolidate the Metropolitan Area Building and Construction Department (MABCD) Board of Code Standards and Appeals ("Joint Board"); and

**WHEREAS**, the Sedgwick County Board of County Commissioners adopted the Wichita-Sedgwick County Unified Building and Trade Code ("UBTC") on November 21, 2012, and the City of Wichita adopted the UBTC on December 4, 2012; and

**WHEREAS**, Article 1, Section 5 of the UBTC provides for the terms of appointments to said Joint Board; and

**WHEREAS**, Article 2, Section A of the UBTC authorizes said Joint Board and the qualifications for members of same.

**WHEREAS**, a vacancy was created by the resignation of Daryl Crotts;

**WHEREAS**, it is the desire of the Sedgwick County Board of Commissioners appoint Eric Purkey to fulfill the unexpired term of Daryl Crotts, whose term expires on July 31, 2019; and

**WHEREAS**, it is the desire of the Board of County Commissioners that Eric Purkey be appointed to At-Large Position on the Metropolitan Area Building and Construction Department (MABCD) Board of Code Standards and Appeals ("Joint Board") and that the terms of said members shall be two years from the effective date of appointment.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

Eric Purkey is appointed to the At-Large Position until the term expiration date of July 31, 2019, or until a successor has been appointed, qualified and sworn to the oath of office before the County Clerk.

**BE IT FURTHER RESOLVED** that the member appointed herein shall subscribe to the oath of office prior to assuming duties as a member of said Joint Board.
