TABLE B BUILDING PERMIT FEES

1. Residential – New Build:

On Residential New Build, the building permit shall be 38 cents for each square foot of finished space and 30 cents for each square foot of unfinished space. For non-commercial, accessory structures (all private, non-dwelling structures on residential property), the building permit shall be 25 cents for each square foot of finished space and 20 cents for each square foot of unfinished space. If unfinished space of an accessory structure exceeds 5,000 square feet, the building permit shall be 20 cents for each square foot of unfinished space for the first 5,000 square feet and 10 cents for each additional unfinished square foot thereafter.
