**A RESOLUTION APPOINTING ROB WALL TO POSITION #8 OF THE

**WHEREAS**, the Sedgwick County Solid Waste Management Committee was established pursuant to Sedgwick County Resolution No. 275-2003, and the terms of the membership were amended by Sedgwick County Resolution No. 31-2012; and

**WHEREAS**, it is the desire of the Board of County Commissioners of Sedgwick County to appoint Rob Wall to the Sedgwick County Solid Waste Management Committee, Position #8, the Private Solid Waste Industry position, to fill the unexpired two months (to 12/31/2017) term of Eric Bergin, who relocated due to employment, and a new term of two years which will expire on December 31, 2019.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

Rob Wall shall serve on the Sedgwick County Solid Waste Management Committee, in Position #8, the Private Solid Waste Industry position, and his term shall expire on December 31, 2019.
