- The Lessee is hereby removed from the Agreement and replaced with the Replacement Lessee and all rights and obligations of the Lessee are transferred to the Replacement Lessee.

All other terms and conditions of the Original Lease Agreement, and all amendments thereto, are retained and shall remain in full force and effect and shall govern the actions and obligations of the parties unless specifically accepted or otherwise noted above.
