**A RESOLUTION RE-APPOINTING COMMISSIONERS DAVID T. DENNIS, RICHARD RANZAU AND JAMES M. HOWELL TO THE WICHITA AREA METROPOLITAN PLANNING ORGANIZATION (WAMPO)**

**WHEREAS**, 23 U.S.C. § 134 requires a continuous, comprehensive, and cooperative transportation planning process to be undertaken in urbanized areas with population greater than fifty-thousand persons through a metropolitan planning organization;

**WHEREAS**, on August 6, 2013, WAMPO Redesignation Agreement for Cooperative Transportation Planning between the Kansas Secretary of Transportation, City of Andale, City of Andover, City of Bel Aire, City of Cheney, City of Colwich, City of Derby, City of Eastborough, City of Goddard, City of Haysville, City of Kechi, City of Maize, City of Mount Hope, City of Mulvane, City of Park City, City of Rose Hill, City of Valley Center, City of Wichita, Butler County, Sedgwick County, and Sumner County, the Wichita Area Metropolitan Area Planning Organization (WAMPO) was redesignated as the metropolitan planning organization for the area;

**WHEREAS**, pursuant to 23 U.S.C. § 134(d)(2)(A), WAMPO's Transportation Policy Body shall serve as the forum for cooperative decision-making and shall include four (4) Sedgwick County elected officials as appointed by the Board of County Commissioners, which appointees serve at the pleasure of the Board of County Commissioners;

**WHEREAS**, WAMPO per the membership agreement and bylaws, the Board of County Commissioners of Sedgwick County, Kansas, may appoint four (4) Sedgwick County elected officials as appointed the Board of County Commissioners of Sedgwick County, Kansas;

**WHEREAS**, it is the desire of the majority of the Board of County Commissioners of Sedgwick County, Kansas, to re-appoint David T. Dennis, Third District Commissioner, Richard Ranzau, Fourth District Commissioner, James M. Howell, Fifth District Commissioner, and Kelly Arnold, County Clerk, to the WAMPO Transportation Body; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

Consent is hereby given to the re-appointment of Commissioners David T. Dennis, Richard Ranzau and James M. Howell as well as County Clerk Kelly Arnold to the WAMPO so long as said appointees remain Sedgwick County, Kansas, elected officials and at the pleasure of the Board of County Commissioners of Sedgwick County, Kansas


