The Board of County Commissioners (the “Board”) of Sedgwick County, Kansas (the “County”) is hereby requested pursuant to K.S.A. 12-1741a, as amended, to approve adoption of a resolution by the governing body of the City of Wichita, Kansas (the “City”) regarding the issuance by the City of the above referenced Taxable Industrial Revenue Bonds (the “Bonds”) to finance the cost of acquiring, modifying and equipping manufacturing facilities, purchasing machinery and equipment and related capital investments in the Wichita-area aircraft manufacturing facilities and operation of Textron Aviation Inc., and its wholly owned subsidiaries (the “Project”), a portion of which are located in unincorporated territory in Sedgwick County, Kansas, but within 3 miles of the limits of the City. Approval may be affirmatively made by action of the Board, or will be deemed made if the Board fails to disapprove the issuance of the Bonds within seven business days after its next regular meeting following receipt of this request.
