

RESOLUTION NO. __-2018

A RESOLUTION DECLARING IT NECESSARY TO BUILD OR REPAIR EXISTING BRIDGES IN THE COUNTY UNDER THE AUTHORITY OF K.S.A. 68-1103; PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION BONDS TO PAY THE COSTS THEREOF (2018 BRIDGE PROJECTS).

WHEREAS, K.S.A. 68-1103, as amended (the “Act”) provides, in part, that the Board may determine, by resolution, that it is necessary to build or repair any road, bridge or culvert to meet the demands of present day traffic, and to issue general obligation bonds of the County to pay the costs thereof, if sufficient funds are not available in the County treasury; and

WHEREAS, the Board hereby finds and determines that certain existing bridges in the County need to be built or repaired, that sufficient funds therefor are not available and general obligation bonds of the County should be issued to pay the costs of building or repairing such bridges under the authority of the Act.

THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS:

SECTION 1. Project Authorization. It is hereby determined that the following bridge projects be built or repaid in accordance with plans and specifications developed or approved by Sedgwick County Public Works (the “Projects”) at the estimated cost allocations hereinafter set forth:

B-479	Bridge on Pawnee between 143 rd St. E. and 159 th St. E.	<u>800,000</u>
	Total	\$2,850,000

SECTION 2. Financing Authority. \$2,850,000 of costs of the Projects and associated financing costs shall be paid by the issuance of general obligation bonds (the “Bonds”) of the County under the authority of the Act.

SECTION 3. Reimbursement Authority. The Bonds authorized and issued pursuant to this Resolution may be used to reimburse Project expenditures made on or after the date which is 60 days before the date of this Resolution, pursuant to Treasury Regulation 1.150-2.

SECTION 4. Effective Date. This Resolution shall take effect and be in force from and after its adoption.
