**SEDGWICK COUNTY RESOLUTION NO. -2018**

**WHEREAS**, the City of Wichita and Sedgwick County have collaborated to establish a new joint law enforcement training center located on the campus of Wichita State University which became operational in January 2018;

**WHEREAS**, both governing bodies wish to recognize Mike Hill and Richard LaMunyon for their contributions to law enforcement and their extensive efforts to establish the joint law enforcement training center;

**WHEREAS**, Richard LaMunyon served as a law enforcement officer for the City of Wichita for over 25 years and was Chief of Police from 1976 to 1989. Chief LaMunyon was the longest serving and youngest Chief of Police for the City of Wichita;

**WHEREAS**, Mike Hill served as a law enforcement officer for the City of Wichita and Sedgwick County for over 37 years and was Sheriff for Sedgwick County from 1985 to 2001;

**WHEREAS**, both Mike Hill and Richard LaMunyon have been instrumental to the planning and development of the joint law enforcement training center;

**WHEREAS**, both Mike Hill and Richard LaMunyon stood up before the city and county in 1985, advocating for shared training between their entities, highlighting the cost savings, expanded knowledge base and comradery such a measure would bring under a shared facility. The measure passed, and recruits began using a shared facility; and

**WHEREAS**, the Board of County Commissioners of Sedgwick County and the City Council for the City of Wichita wish to honor these individuals for their contributions to the development of the joint training center and their numerous contributions to the community.

**NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS AND THE CITY COUNCIL OF THE CITY OF WICHITA, KANSAS, THAT:**

**SECTION 1.**

To honor the accomplishments of Mike Hill and Richard LaMunyon, the Board of County Commissioners of Sedgwick County and the City of Wichita City Council request that the tactical training room located within the training center be named as follows:

The Hill/LaMunyon Tactical Defense Training Room

This Joint Ordinance and Resolution shall be effective upon adoption by both governing bodies.
