WHEREAS, County and DCF have executed a Contract dated February 3, 2010, providing for certain goods and services ("Contract");

WHEREAS, Contract allows for annual renewal; and

WHEREAS, County and DCF wish to continue said Contract and amend certain provisions therein.

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration, County and DCF do hereby mutually covenant and agree as follows:

SECTION 1. The Contract and any subsequent addenda shall be renewed for the period commencing January 1, 2018 and continuing through December 31, 2018.

SECTION 2. All references in the Contract to "Secretary of Kansas Department of Social and Rehabilitation Services" or "SRS" shall be amended to refer to the "Kansas Department of Children and Families" or "DCF."

SECTION 3. The Contract, section 5, shall be amended to read as follows:

Contractor and DCF expressly understand and agree that in no event shall the total, full and complete compensation and reimbursement for cost share of DCF paid hereunder to Contractor by DCF exceed the maximum amount of Forty Six Thousand Fifty-Six Dollars (\$46,056), which amount represents one-third of the cost share of personnel and benefits, contractual services and commodities for EMCU.

SECTION 6. All terms and conditions of said Contract and subsequent addenda which are not in conflict with this Amendment shall remain as provided for in the Contract.
