- 3. The Chairman is authorized to sign all necessary documents and agreements that support this objective, subject to review of the Sedgwick County Counselor's Office.
- 4. This Resolution shall take effect and be in force from and after its approval and adoption by the Board of County Commissioners of Sedgwick County, Kansas, and upon its publication in the official county newspaper.
