**A RESOLUTION APPOINTING DANIELLE YOUNG  
TO THE STORMWATER MANAGEMENT ADVISORY BOARD**

**WHEREAS**, the Stormwater Management Advisory Board ("SMAB") was established pursuant to Sedgwick County Resolution No. 242-2007;

**WHEREAS**, Resolution No. 242-2007 was subsequently repealed and replaced by Sedgwick County Resolution No. 188-2012 which provides that each County Commissioner is to appoint one representative to the SMAB;

**WHEREAS**, said representative serves at the pleasure of the appointing commissioner or until the appointing commissioner leaves office;

**WHEREAS**, each of the five (5) Sedgwick County Board of County Commissioners appoint one member to SMAB; the Sedgwick County Board of County Commissioners as a whole appoints positions for each of the ten (10) cities in Sedgwick County as well as three (3) watershed districts for a total of 18 positions on the Board;

**WHEREAS**, Randall Oliver is currently serving in the City of Cheney's position and he is retiring so the City of Cheney nominated Danielle Young as a replacement for this position;

**WHEREAS**, Chairman David Dennis wishes to appoint Danielle Young to the SMAB to fill the vacancy left by Randall Oliver who is retiring; and

**WHEREAS**, it is the desire of the Board of County Commissioners to appoint Danielle Young to the Stormwater Management Advisory Board, effective April 4, 2018.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS that:**

Danielle Young is hereby appointed to the Stormwater Management Advisory Board and shall serve at the pleasure of the appointing commissioner or until the appointing commissioner leaves office.
