THIS AGREEMENT, made and entered into this day of, 2018, by and between David R. and Tammy L. Doyel (hereinafter referred to as "Owners") and Sedgwick County, Kansas (hereinafter referred to as "County").		
WHEREAS, Owners have requested that paving be constructed to serve the following described property:		
	North Half of the East Half of the Northwest of Section 35, Township 26 South, East, Sedgwick County, Kansas	
And,		
WHEREAS, 37 th Street North between 127 th St. East and 143 rd St. East is located within right-of-way under the jurisdiction of County; and,		
WHEREAS, Owners have requested that County construct street paving to serve the above-described property and reimburse County for a portion of the cost of said construction and transfer any ownership interests in the paving to the County; and,		
WHEREAS, the paving of 37 th Street North between 127 th St. East and 143 rd St. East, hereinafter referred to as "Project", has been scheduled for construction by the County as a part of Capital Improvement Project R342;		
NOW THEREFORE, it is agreed between the Owners and the County as follows:		
1.	County agrees to build the Project. County shall pay all costs associated with said Project.	
2.	Owners agree to reimburse County for a portion of the cost of Project. Said reimbursement shall be at the rate of 25% of total the total cost of Project but shall not exceed \$100,000.00. Upon completion of the project, County shall bill Owners for their share. Owners shall make full payment to County within 30 days of billing.	
3.	Owners agree that County shall have full and complete title to the Project.	
4.	Owners indemnify and hold the County harmless from any and all liability relating to the design and construction of the Project.	
5.	Neither this Agreement nor any rights or obligations created by it shall be	

amended by either party without the prior written consent of the other.

- 6. Neither this Agreement nor any rights or obligations created by it shall be assigned or otherwise transferred by either party without the prior written consent of the other.
- 7. This Agreement shall be interpreted under and governed by the laws of the State of Kansas.
- 8. This Agreement contains all the terms and conditions agreed upon by both parties.

 No other understandings, oral or otherwise, regarding the subject matter of this Agreement shall be deemed to exist or to bind any of the parties hereto.
