**A RESOLUTION APPOINTING PEGGY O'DONNELL TO THE  
SEDGWICK COUNTY INTELLECTUAL AND DEVELOPMENTAL DISABILITIES

**WHEREAS**, K.S.A. 19-4002a and Sec. 14-111 of the *Sedgwick County Code* provide for the appointment of members to the Sedgwick County Intellectual and Developmental Disabilities Advisory Board and their terms of appointment;

**WHEREAS**, the Board of County Commissioners of Sedgwick County, Kansas, approved Commissioner David M. Unruh's appointment of Judy Whiley on September 7, 2016, for a four year term to expire on February 9, 2020;

**WHEREAS**, Judy Whiley submitted her resignation on November 9, 2017; and

**WHEREAS**, it is the recommendation of Commissioner David M. Unruh that Peggy O'Donnell be appointed to the Sedgwick County Intellectual and Developmental Disabilities Advisory Board to fill the unexpired term previously held by Judy Whiley.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS**, that:

Peggy O'Donnell is hereby appointed to the Sedgwick County Intellectual and Developmental Disabilities Board and her term shall expire on February 9, 2020, except that in the event the Commissioner making the recommendation for the appointment herein leaves office for any reason, said term shall expire and the member shall then serve until a successor has been duly appointed.


