A RESOLUTION RE-APPOINTING TODD HARP IN THE POSITION OF REGISTERED WATER WELL DRILLER AND CHRISTOPHER BROHM IN THE POSITION OF ONSITE WASTEWATER ADVISORY BOARD MEMBER ON THE SEDGWICK COUNTY WATER WELL ADVISORY BOARD

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, is empowered by home rule powers to establish a Water Well Advisory Board;

WHEREAS, Sedgwick County Resolution No. 189-2005 provides for the appointment by the Board of County Commissioners, Sedgwick County, Kansas, of members thereto and their four-year term of membership;

Christopher Brohm, a current member of the Sedgwick County Water Well Advisory Board as an Onsite Wastewater Advisory Board Member, is hereby re-appointed and his term shall expire on June 5, 2022.
