RESOLUTION RECLASSIFYING CERTAIN ROADS FROM THE ROCKFORD TOWNSHIP, ROAD SYSTEM TO THE SEDGWICK COUNTY HIGHWAY SYSTEM. SPECIFICALLY, 73<sup>RD</sup> STREET SOUTH AND 139<sup>TH</sup> STREET EAST ADJACENT TO THE SOUTH AND WEST BOUNDARIES OF COOK AIR FIELD, RESPECTIVELY.

WHEREAS, The Board of County Commissioners of Sedgwick County, Kansas, has received a recommendation from the County Engineer that 73<sup>rd</sup> Street South and 139<sup>th</sup> Street East adjacent to the south and west boundaries of Cook Air Field, respectively, should be reclassified as county roads pursuant to K.S.A. 68-506,

WHEREAS, the County Engineer has determined that these sections of road will receive increased traffic volumes due to construction of improvements thereto.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:

1. 73<sup>rd</sup> Street South adjacent to the south boundary of Cook Air Field be and is hereby reclassified from the Rockford Township road system to the Sedgwick County highway system.
2. 139<sup>th</sup> Street East adjacent to the west boundary of Cook Air Field be and is hereby reclassified from the Rockford Township road system to the Sedgwick County highway system.
3. The County Engineer is hereby directed to notify Rockford Township to make proper entries recording these reclassifications.
