Witnesseth:

WHEREAS, this Agreement is made under the authority of K.S.A. 12-2908, et seq; and

WHEREAS, each governing body, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, each governing body finds that the performance of this Agreement is in the best interests of both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement; and

WHEREAS, the COUNTY, JAG Grantee, agrees to provide the CITY, JAG Subgrantee, \$187,847.50 from the JAG award for the 2018 Safe and Secure Community Project; and

**WHEREAS**, the CITY and COUNTY believe it to be in their best interests to reallocate the JAG funds.

NOW THEREFORE, the COUNTY and CITY agree as follows:

#### Section 1.

COUNTY agrees to pay CITY a total of \$187,847.50 of JAG funds.

### Section 2.

CITY agrees to use \$187,847.50 for the <u>2018 Safe and Secure Community Project</u> until 9-30-2021 and in so doing will comply with all requirements of the JAG Grant Program including any Special Conditions issued at the time of award.

Each party to this Agreement will be responsible for its own actions in providing services under this Agreement and shall not be liable for any civil liability that may arise from the furnishing of the services by the other party.

### Section 6.

The parties to this Agreement do not intend for any third party to obtain a right by virtue of this Agreement.

#### Section 7.

By entering into this Agreement, the parties do not intend to create any obligations express or implied other than those set out herein; further, this Agreement shall not create any rights in any party not a signatory hereto.
