### 1. Provide a description that addresses the entire scope of the proposed project.

Sedgwick County Department of Public Services partners with Sedgwick County COMCARE to provide tenant-based rental assistance to chronically homeless persons with Severe and Persistent Mental Illness, within the city of Wichita and Sedgwick County. And while COMCARE is the primary referral source for the targeted population, supported services may be provided by other community agencies.

The program is designed to promote residential stability for those with severe and persistent mental illness, operating with a commitment to eliminating as many barriers possible, a commitment to the Housing First approach, as well as utilizing the VI-SPDAT assessment tool. The program works with households to rapidly place/stabilize them into permanent housing without preconditions such as sobriety, treatment, criminal history, or a minimum income threshold. The program objective is to provide clients with skills to increase self-sufficiency, financial stability, and self-determination through permanent housing for the homeless persons with disabilities within the city of Wichita and Sedgwick County.
