Sedgwick County Department of Public Services partners with Sedgwick County COMCARE, Miracles, Inc. and UKSM-W MPA Midtown Clinic (UKSM-W MPA) to provide tenant-based rental assistance to literally and chronically homeless persons within the city of Wichita and Sedgwick County.

The program is designed to promote residential stability for those with severe and persistent mental illness, substance abuse issues, and/or HIV/AIDS-related illness. The program operates with a commitment to eliminating as many barriers possible, a commitment to the Housing First approach, as well as utilizing the VI-SPDAT assessment tool to determine risk and prioritization. The program dedicates a number of beds for chronically homeless persons.

The program works with households to rapidly place/stabilize them into permanent housing without preconditions such as sobriety, treatment criminal background, or a minimum income threshold. The program purpose is to provide clients with skills to increase self-sufficiency, financial stability, and selfdetermination through permanent housing for the homeless persons with disabilities within the city of Wichita and Sedgwick County.


