Explain the circumstances that led HUD to recapture funds from the most recently expired grant term related to this renewal project request.

The recapture of funds is due individuals who successfully transitioned from the program into Section 8, Public Housing, or self-sufficiency. In addition, applicants secured income and began contributing toward their rent. A third contributing factor is that the program is funded for 12 4-bedroom units; Due to predominantly smaller households, rarely is a 4-bedroom voucher necessary. The program will pursue an amendment of the specific 12 4-bedroom apartments correspondingly. Another factor impacting the recapture of funds are the ongoing challenges encountered by providers when determining and documenting Chronic Homelessness.

3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Sedgwick County Department of Public Services partners with Sedgwick County COMCARE, Miracles, Inc. and UKSM-W MPA Midtown Clinic (UKSM-W MPA) to provide tenant-based rental assistance to literally and chronically homeless persons within the city of Wichita and Sedgwick County.

The program is designed to promote residential stability for those with severe and persistent mental illness, substance abuse issues, and/or HIV/AIDS-related illness. The program operates with a commitment to eliminating as many barriers possible, a commitment to the Housing First approach, as well as utilizing the VI-SPDAT assessment tool to determine risk and prioritization. The program dedicates a number of beds for chronically homeless persons.

The program works with households to rapidly place/stabilize them into permanent housing without preconditions such as sobriety, treatment criminal background, or a minimum income threshold. The program purpose is to provide clients with skills to increase self-sufficiency, financial stability, and self-determination through permanent housing for the homeless persons with disabilities within the city of Wichita and Sedgwick County.
