

**A RESOLUTION APPOINTING CHARLES MARK CLARK AS
INTERIM COUNTY APPRAISER FOR SEDGWICK COUNTY**

WHEREAS, Michael S. Borchard retired as Sedgwick County Appraiser September 1, 2018; and

WHEREAS, pursuant to K.S.A. 19-430 (a), the Board of County Commissioners may appoint an Interim County Appraiser to serve for a period of up to six months pending the appointment of an eligible County Appraiser; and

WHEREAS, it is the desire of the Board of County Commissioners to appoint Charles Mark Clark as Interim County Appraiser for Sedgwick County for a period of up to six months pending the appointment of an eligible County Appraiser; and

WHEREAS, pursuant to K.S.A. 19-430 (a), the appointment of an Interim County Appraiser is subject to the approval of the Kansas Department of Revenue's Director of the Division of Property Valuation; and

WHEREAS, David Harper, Director of the Division of Property Valuation has approved Charles Mark Clark's appointment as Interim County Appraiser to serve for a period of up to six months pending the appointment of an eligible County Appraiser (see attached letter of approval); and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that Charles Mark Clark is hereby appointed as Interim County Appraiser for Sedgwick County for a period of up to six months pending the appointment of an eligible County Appraiser. The term of this appointment is effective as of September 1, 2018 and shall expire upon the appointment of an eligible County Appraiser or March 1, 2019, whichever occurs first.
