**A RESOLUTION APPOINTING CODY CORBETT TO THE ALTERNATE  
CLASSIFIED EMPLOYEE POSITION OF THE SEDGWICK COUNTY  
GRIEVANCE BOARD**

**WHEREAS**, pursuant to Sedgwick County Personnel Policy and Procedures Manual, Section 4.502, paragraph III(I), the Grievance Hearing Board shall consist of three members and three alternate members appointed by and serving at the pleasure of the Board of County Commissioners for a term of two years; and

**WHEREAS**, such appointees shall include one classified Sedgwick County employee, one Sedgwick County department head, and one elected official of Sedgwick County, who shall serve as chair;

**WHEREAS**, three alternate members shall be appointed in the same manner;

**WHEREAS**, a vacancy exists on the Grievance Board in the Alternate Classified Employee Position due to the resignation of Traci Addington, on July 18, 2018, whose term expires on May 9, 2019;

**WHEREAS**, it is the desire of the Board of County Commissioner of Sedgwick County, Kansas, to appoint Cody Corbett to fill this unexpired term in the Alternate Classified Employee position; and

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

Cody Corbett is duly appointed by the Board of County Commissioners to the Sedgwick County Grievance Board in the Alternate Classified Employee position to fill the unexpired term which shall herein expire on May 9, 2019, or at the pleasure of the Board of County Commissioners.


