A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK  
COUNTY, KANSAS SITTING AS THE GOVERNING BOARD OF THE FIRE DISTRICT  
ONE, SEDGWICK COUNTY, KANSAS, DIRECTING TRANSFER OF FUNDS  
FROM THE FIRE DISTRICT GENERAL FUND TO  
THE FIRE DISTRICT SPECIAL EQUIPMENT FUND

WHEREAS, pursuant to K.S.A. 19-3601, the Board of County Commissioners shall be  
and does constitute the governing body of Sedgwick County Fire District No. One; and

WHEREAS, K.S.A. 19-3612c authorizes the governing body of any fire district orga-  
nized under K.S.A. 19-3601 to transfer from the general fund of the district money credited to  
such fund, and subject to legal expenditure, which in the opinion of the governing body will not  
be needed for general operating expenses in such year, to a special fund to be established for the  
acquisition of fire-fighting equipment, apparatus or machinery or land and buildings to be used  
for fire-fighting purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF SEG-  
WICK COUNTY FIRE DISTRICT ONE, that:

The Chief Financial Officer, after consideration of the needs of Sedgwick County Fire  
District No. 1 and consultation with the Fire Chief, shall transfer an amount of money (as deter-  
mined by the CFO) to the Fire District Special Equipment Fund to provide for the acquisition of  
fire-fighting equipment, apparatus or machinery or land and buildings to be used for fire-fighting  
purposes.
