**A RESOLUTION APPOINTING SHERRY LIVINGSTON TO THE CITIZENS  
ADVISORY BOARD IN THE THIRD COUNTY COMMISSION DISTRICT OF

**WHEREAS**, pursuant to K.S.A. 19-101, *et seq.*, the Sedgwick County Board of County Commissioners may exercise the powers of home rule to determine its local affairs and government;

**WHEREAS**, the Third District Citizens Advisory Board (CAB) was established by the Board of County Commissioners pursuant to Resolution 22-2017 on February 15, 2017. Resolution 22-2017 was amended on March 22, 2017 by Resolution 48-2017, modifying the number of members to not more than eleven (11);

**WHEREAS**, Jessica Mounts served a term from her appointment on March 22, 2017, until her resignation was accepted by the Board of County Commissioners, Sedgwick County, Kansas, on October 3, 2018, which leaves a vacancy; and

**WHEREAS**, pursuant to said resolution, it is the desire of Third District Sedgwick County Commissioner David Dennis for the Board of Sedgwick County Commissioners to appoint Sherry Livingston, a resident of the Third District, to the CAB to fill the vacancy due to the resignation of Jessica Mounts;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF Sedgwick  
COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

Sherry Livingston is hereby appointed to serve on the CAB at the pleasure of the Board, as provided in Sedgwick County Resolution 22-2017 (and amendments thereto):
