**A RESOLUTION APPOINTING JERI MYERS TO THE  
SEDGWICK COUNTY ADVISORY COUNCIL ON AGING**

**WHEREAS**, originally established on September 21, 1983, by the Board of County Commissioners pursuant to Resolution 249-1983. Resolution 249-1983 was repealed by the Resolution No. 16-1987. In 2011, the physical disabilities component was administratively added into the purview of the Sedgwick County Advisory Board on Aging. Therefore, on November 28, 2018, Resolution 165-2018 was passed re-establishing the Advisory Council on Aging to be the Sedgwick County Advisory Council on Aging and Physical Disabilities (Sedgwick County Code Article VI, Division 2, Sec. 2-161 – Sec. 2-165);

**WHEREAS**, Clifford Helms was appointed to this position on February 3, 2016, by recommendation of Commissioner James M. Howell and the approval by the Board of County Commissioners;

**WHEREAS**, a vacancy has been created due to the passing of Clifford Helms; and

**WHEREAS**, it is the recommendation of Commissioner James M. Howell that Jeri Myers be appointed to the Sedgwick County Advisory Council on Aging to fill the unexpired term of Clifford Helms.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that**

Jeri Myers is hereby appointed to the Sedgwick County Advisory Council on Aging. The term of this appointment shall expire on June 9, 2019, except that in the event the Commissioner making the recommendation for the appointment herein leaves office for any reason, the said term shall expire and the member shall then serve until a successor has been duly appointed.
