That portion of Reserve B, Wood River 2nd Addition to Sedgwick County, Kansas lying 25 feet on either side of the following described center line: Beginning at a point 78.60 feet East and 2910 feet North of the Southwest corner of Section 14, Township 28 South, Range 1 East of the 6th Principal Meridian, Sedgwick County, Kansas, said point of beginning also described as Northeast Corner of Lot 2, Block 9,of Sunview Heights Addition; Thence West 47.88 feet to the point of curvature of a 208.35 foot radius curve to the right subtending a central angle of 34°42′; thence along said 208.35 foot radius curve a distance of 126.18 feet to its point of tangency; thence along said tangent a distance of 547.06 feet to the point of curvature of a 204.63 foot radius curve to the left subtending a central angle of27°24′; thence along said 204.63 foot radius curve a distance of 97.86 feet to its point of tangency; thence along said tangent to the left Mean High Bank of the Arkansas River.
