A RESOLUTION TEMPORARILY SUSPENDING A CEREAL MALT BEVERAGE LICENSE FOR CERTAIN DATES

WHEREAS, K.S.A. 41-2703 authorizes boards of county commissioners to issue licenses for the retail sale of cereal malt beverages;

WHEREAS, the Sedgwick County Zoological Society, Inc. ("Society") currently holds a cereal malt beverage license issued by the Board of Commissioners of Sedgwick County, Kansas ("County"), which expires on December 31, 2019;

WHEREAS, Society anticipates holding events during 2019 in which licensed caterers will provide to attendees beverages containing alcoholic liquor;

WHEREAS, pursuant to K.S.A. 41-2704(g), alcoholic liquor may not be possessed on a premises which is licensed as a cereal malt beverage establishment;

WHEREAS, the Society requests, supports and consents to the voluntary suspension of its cereal malt beverage license for certain dates on which alcoholic liquor will be possessed on zoo premises for special events; and

WHEREAS, it is in the best interests of the Society to have its cereal malt beverage license suspended on certain dates in order to comply with K.S.A. 41-2704(g).

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:
