**A RESOLUTION REAPPOINTING TONY MARTINEZ TO THE

**WHEREAS**, Commissioner Michael O'Donnell previously appointed Tony Martinez on June 6, 2017, to serve on the Sedgwick County Solid Waste Management Committee in Position No.12 for a term which expired on December 31, 2018; and

**WHEREAS**, it is the desire of Commissioner Michael O'Donnell to reappoint Tony Martinez to the Sedgwick County Solid Waste Management Committee in Position No.12.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

Tony Martinez shall be reappointed to the Sedgwick County Solid Waste Management Committee and his term shall expire on December 31, 2020.
