A RESOLUTION APPOINTING DAN NEWFARMER TO THE SEDGWICK COUNTY ADVISORY BOARD FOR ONSITE WASTEWATER SYSTEM INSTALLATION AND MAINTENANCE AND SANITARY SERVICE

WHEREAS, the Board of County Commissioners of Sedgwick County, Kansas, is empowered by home rule powers, K.S.A. 19-101(a), to establish an advisory board for onsite wastewater system installation and maintenance and sanitary service;

WHEREAS, Sedgwick County Resolution 148-2005 provides for the appointment of seven (7) persons with required qualifications to serve on said Advisory Board;

WHEREAS, members are appointed by and serve at the pleasure of the Board of County Commissioners of Sedgwick County, Kansas, for a term of four (4) years and may continue to serve until another appointment is made;

WHEREAS, John Ferguson was appointed to said Board in an Installer Position on September 28, 2011, and his term expired on September 27, 2015; and

WHEREAS, it is the recommendation of the Board of County Commissioners of Sedgwick County, Kansas, that Dan Newfarmer be appointed to the Sedgwick County Advisory Board for Onsite Wastewater System Installation and Maintenance and Sanitary Service in an Installer Position, to fill the position formerly held by John Ferguson, for a term to expire on February 12, 2023.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:

Dan Newfarmer is hereby appointed to the Sedgwick County Advisory Board for Onsite Wastewater System Installation and Maintenance and Sanitary Service in an Installer Position. The term of this appointment shall expire on February 12, 2023.
