### **A RESOLUTION REAPPOINTING RANDY WIRTHS TO THE SEDGWICK COUNTY ADVISORY BOARD FOR ONSITE WASTEWATER SYSTEM INSTALLATION AND MAINTENANCE AND SANITARY SERVICE**

**WHEREAS**, the Board of County Commissioners of Sedgwick County, Kansas, is empowered by home rule powers, K.S.A. 19-101(a), to establish an advisory board for onsite wastewater system installation and maintenance and sanitary service;

**WHEREAS**, Sedgwick County Resolution 148-2005 provides for the appointment of seven (7) persons with required qualifications to serve on said Advisory Board;

**WHEREAS**, members are appointed by and serve at the pleasure of the Board of County Commissioners of Sedgwick County, Kansas, for a term of four (4) years and may continue to serve until another appointment is made;

**WHEREAS**, Randy Wirths was appointed to said Board on December 18, 2013, in a Hauler Position and his term expired on December 10, 2017; and

**WHEREAS**, it is the recommendation of the Board of County Commissioners of Sedgwick County, Kansas, that Randy Wirths be reappointed to the Sedgwick County Advisory Board for Onsite Wastewater System Installation and Maintenance and Sanitary Service in a Hauler Position for a term to expire on February 12, 2023.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS**, that:

Randy Wirths is hereby reappointed to the Sedgwick County Advisory Board for Onsite Wastewater System Installation and Maintenance and Sanitary Service in a Hauler Position. The term of this appointment shall expire on February 12, 2023.
