**A RESOLUTION APPOINTING SEAN GATES TO  
THE SEDGWICK COUNTY MENTAL HEALTH ADVISORY BOARD**

**WHEREAS**, the Board of County Commissioners of Sedgwick County, Kansas, has established, pursuant to K.S.A. 19-4002a and Sedgwick County Resolution No. 199-1986 (and amendments thereto), a Mental Health Advisory Board to make certain recommendations regarding mental health services and programs in Sedgwick County;

**WHEREAS**, Sec. 14-76 of the *Sedgwick County Code* provides for the appointment of members to the Sedgwick County Mental Health Advisory Board;

**WHEREAS**, pursuant to Sec. 14-76 of the *Sedgwick County Code*, in the event the Commissioner recommending the appointment of said member leaves office for any reason, said term shall expire;

**WHEREAS**, upon recommendation of Commissioner Richard Ranzau, Treatha Brown-Foster, was appointed to said board for a term of four years;

**WHEREAS**, upon the departure of Commissioner Richard Ranzau from office, the regular term of Treatha Brown-Foster has now expired, leaving a vacancy; and

**WHEREAS**, it is the recommendation of Commissioner Lacey D. Cruse that Sean Gates be appointed to the Sedgwick County Mental Health Advisory Board for a term of four years.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, that:**

Sean Gates is hereby appointed to the Sedgwick County Mental Health Advisory Board. The term of this appointment shall expire on March 12, 2023, or as otherwise provided in *Sedgwick County Code*, sec. 14-76.
