1. DEFERRED COMPENSATION PLAN FOR HUMAN RESOURCES

"Recommendation is to accept the best proposal from Great-West Life & Annuity Insurance Company and execute a five year contract.

"I would like to point out an adjustment that was made in the minutes. I received a phone call this morning from our consultant, Hyas Group, the current plan was originally reported as \$364,556.53 as an annual payment or 89 basis points. That should have been \$280,890.74 or 68 basis points. There was a duplication in the record keeping revenue which represents 21 basis points. Long story short, on the savings between the new proposed plan versus the current plan, instead of a 44 percent savings, it's actually a 27 percent savings. This does not change, however, the numbers that are found in table, nor our recommendation and we wanted to point out that adjustment in the minutes.

SELECTION OF ONE MEMBER OF THE BOARD OF COUNTY COMMISSIONERS TO SERVE AS CHAIRMAN THROUGH JANUARY 11, 2017.

Presented by: Chairman Richard Ranzau.

RECOMMENDED ACTION: List slate of nominees and vote on each in the order listed.

Chairman Ranzau said, "Commissioner Peterjohn."

Commissioner Peterjohn thanked the Chairman and said, "Before we get involved in that specific item, I think we're at a point at the meeting where there aren't a lot of responsibilities that the chair pro-tem has to do as part of this position during the Board during the course of the year. One is a presentation to the outgoing Chairman of a plaque for recognition of his service as Chairman of the County Commission. I've had the privilege of serving with Richard since he joined the Commission in 2011. It's been a challenging year and I think we are doing some good things for the citizens of Sedgwick County and laying the groundwork for a better future, so it is my honor and privilege to be able to present to you, Mr. Chairman, in recognize of your service,

your Chairman's plaque for 2015. Congratulations. Enjoy."

Chairman Ranzau said, "Thank you very much, Commissioner. Well, it has been a good, interesting and challenging year. I want to take a few moments to say a few things and thank some people and kind of maybe review this past year. First of all, I have to thank my family for their patience and support throughout this. Certainly, being Chairman, being on the Commission in general can take time away from the family, and they're very understanding and supportive of that. I also want to thank the employees and staff of Sedgwick County who do tremendous work every day of the year. We appreciate all the work that they're doing.

"I do, however, want to thank one person in particular, and that's Assistant County Manager Ron Holt. This last year, we've gone through lot of changes. For me, it seems like it's been the busiest time we've had as a Commission simply because of some of the personnel changes, very important personnel changes. County Manager Bill Buchanan retired after 24 years. We also had County Counselor Rich Euson who retired. MAPD (Metropolitan Area Planning Department) Director John Schlegel retired as well. Those are three important positions that we had to fill, simultaneously, as we were going through the budget process. When Bill left, we had to finish the budget process, and Ron filled in during that transition time. We were doing all of these searches simultaneously and having all of these meetings, and then when Mike came onboard, he's assisted with that transition as well and has done a tremendous job, and without his hard work and effort, it just wouldn't have been possible, so I want him to know just how thankful we are for his efforts.

"And then lastly, I also want to thank the taxpayers of Sedgwick County, they are the ones that pay the taxes to provide the services that we provide and do the things that we do.

"It's been a busy year. I want to talk about some of the things that we've done. I think we've made some significant positive changes here at Sedgwick County, and I think Sedgwick County was already a shining example of the right way to do things in local government, but I think we continue to improve and get better and move the county forward and improve our financial position as we move forward.

"You know, there's been a lot of discussion about the budgets, and that's a big part of what we do our discussions actually began with a retreat, back in February, where we introduced our goals and these goals will carry through the 2016 budget process and are helping to put the county on a stronger financial footing for our future.

"Some of the highlights of what we've done include the Tag Office. We did approve a new Tag Office, which I know the County Treasurer wanted for years and years and years. So we're finally moving forward on that. We've also made a decision on the 271 building, which will find space with MABCD (Metropolitan Area Building and Construction Department) and MAPD space, something they've been wanting for a long time. Sedgwick County has also taken the lead in cooperating with the City of Wichita on an RFP (Request for Proposal) for the Law Enforcement Training Center, so we will continue down that process and we will also get that need met, because that's something that's been ongoing for a long time, as well.

"We sold some land on Northeast Park that got back on the rolls and brought in new revenue. We've also been allowing concealed carry in Sedgwick County buildings, which we've taken a leadership role on that, and I think that's turned out very well, and I think both our citizens and our employees appreciate that. We've also done some things as a result of employee suggestions, removed Environmental Resources into Public Works building. We've reopened the Bait Shop out at the Lake Afton. Both

of these measures will save taxpayer dollars, and these came as a result of suggestions from employees. While it took longer than what I would have liked to get those moves done, I would encourage our new Manager to keep an open ear to employees, because they often have good ideas and know good ways to save money and improve our services out there, and I hope as we go forward we'll continue to do that.

"We also provide new funding for a new EMS (Emergency Medical Services) Station to support an expanded Wesley Medical Center facility in Derby. We also bought land for another EMS station that will be built as well. We reduced the solid waste fee by, I believe, 22 percent, because we had reached that we had more than what we needed. We maintained our mill levy rate and reduced our dependence on bonding for roads and bridges, which in the long run will actually give us more money to provide services and help dig us out of the hole we have created from repetitive and unnecessary borrowing.

"Additionally, we have created the Judge Riddel Boys Ranch Correctional Alternative Program as well as the family engagement component that is being implemented in juvenile programs, as part of prevention to provide family support mechanisms and practices and help reduce recidivism.

"We opened the Community Crisis Center on 635 North Main. This is an expanded crisis program that COMCARE and other community partners with our 23 observation shares, sobering brands and social detox services. This program allows for appropriate crisis response rather than the jail or emergency room, and it provides for greater community capacity and better utilization of resources.

"We've also worked for the legislature to support reducing regulatory burdens as well as a regulatory burden here in Sedgwick County. That increase of cost under the Public Works Projects. We'll continue to work on that as we move well. KDOT broke ground on the I-235 and Kellogg interchange project that Sedgwick County partnered with, partnered on with \$11.6 million. And previously Sedgwick County committed \$10 million of county road funds to the Tyler and Maize interchange on Kellogg in the past. We'll continue to do those sorts of things.

"So it's been a very interesting and challenging year. The last several years, with the new economy, we've had deficits every year that we've had to face and deal with. I don't think that will be any different going forward. I think Sedgwick County remains committed to thoughtful, data driven decisions that will enable us to provide our basic core services while maintaining and in many ways improving our long-term financial stability. Sedgwick County taxpayers can continue to have confidence in knowing this Commission will continue to work for everyone, not just the local minority, but everyone to insure their tax dollars are spent wisely and efficiently. I'm very happy with the progress that we've made. I hope to get a few things done; a few resolutions done that will give continued certainty to the taxpayers and help demonstrate where we're going in Sedgwick County.

"We're working on a few things that will come before the Commission here in the following weeks to be a culmination of this year's work and effort. I want to thank my colleagues and staff for all the support and everything that we've accomplished. With that being said, we haven't been perfect; we've had our challenges. Perhaps one of the biggest challenges that we have had is getting our message out and getting the facts out so the public understands what it is that we are truly doing. As Mr. Wright has said before, we have taken steps to allow public input, we like public input, we like public debate about issues. It is important to have public debate about things that we are really doing and about the facts.

"We live in a day and age where media stories are often driven by emotions and conflict. Sometimes the facts and the truth are a casualty, and so we end up having discussions and debates about things that aren't really happening, and that's not helpful for the community. I think vigorous debate about issues and facts is important and good for our community, but when we debate things that aren't really happening, that's not helpful. We, as a Commission, have to find a way to get the facts out better.

"Unfortunately, that's difficult, because I know that when people aren't interested in getting the facts and telling the facts and telling the story correctly, then it makes it difficult. I'll just throw out an example. There are some people that still believe and are still saying, in the media, that we cut WIC (Women, Infants and Children) benefits. That's factually incorrect. Not even close. In fact, we didn't cut anything out of. Nevertheless, without going through all the stories, there were stories about the budget that we're doing this and doing that, that were just factually incorrect.

"Time and time again, when people would ask me questions, I would explain to them the whole truth, and they would say, oh, I didn't know that. That makes perfect sense. And I've had other Commissioners have the same stories. As we move forward, I want to continue to debate things and have an open discussion, but we've got to do a better job of insuring that we have debates about the real issues and about the real facts and not debates that are centered on misleading information that people are putting out there just to promote their political agenda. That's not helpful to the community. I remain committed, as I said earlier, to thoughtful and data driven decisions. We'll continue to do that, and Mr. Manager, as we move forward, I know we've already had some discussion, we need to work on getting that information out there to all of our public so they can understand what we're doing, and I think that will make our community stronger and better, and we'll have more vigorous and meaningful debates about issues as we move forward.

"So with that being said, Commissioner Peterjohn."

Commissioner Peterjohn said, "Mr. Chairman, the item we have here is selecting one member of the Board of County Commissioners to serve as Chairman from now through January 11th, 2017, and I'd like to make a nomination, if that's in order, at this time."

Chairman Ranzau said, "Yes, you may."

Commissioner Peterjohn said, "I would like to nominate a fellow Commissioner, who I've had the privilege of serving with, but I've known a lot longer than the time that he's been on the Commission, and with the challenge going forward at the state level, I want to nominate one Commissioner who has legislative experience, and that's Jim Howell. I think he would be an outstanding Chairman for 2016."

Chairman Ranzau said, "Commissioner Norton."

Commissioner Norton said, "Yes, Mr. Chair. I'd like to nominate Dave Unruh for Chairman for 2016."

Chairman Ranzau said, "I will be the Chair Pro-Tem by a vote of 4 to 1. Thank you, Commissioners. Next item, please."

Chairman Ranzau said, "Commissioners, is there anything for the 'Other' portion? Commissioner Peterjohn."

Commissioner Peterjohn said, "I would be remiss if I didn't point out Sedgwick County contributed equipment that it was allowed to use for creating mulch or disposing of, I'm not sure if it was just ordinary foliage or Christmas trees, out in Goddard yesterday, and I wanted to point that out as well as obviously mentioned earlier about the winter weather. I would also point out that January 13th is an important day in American history."

"January 13th, 238 years ago there was a sorely dark days during the American revolution, and the British had captured Philadelphia and they were residing in many cases in Patriot's homes, snug quarters inside the city while at this time on this date the Patriot Army was trying to put together a hospital, makeshift hospital for the soldiers who were literally in rags and in some cases close to starvation outside at Valley Forge. If you ever get a chance, it's right outside Philadelphia, and it's a beautiful place now, but I'll tell you, during the winter of 1777 to 1778, it was unimaginable suffering that was going on there, and I think that's important for us to remember as we proceed into 2016 with the challenges going forward.

"Also on this date in 1794, interesting footnote in American history, not a footnote in an unusual sense. Both Vermont and Kentucky entered the Union, and President Washington at that time, in 1794, added two stars to the flag, which we continue to do. Interestingly enough, they had a procedure at that time they thought, hey, let's add an extra, we add two more stripes on the flag, and we actually created a flag that had instead of 13 red and white stripes, it had 15, and of course, that procedure stopped after a number of states. We would have had a very strange looking flag today if we continued that process up to the 50 states we have today.

"January 13th is an important day in American history, and I wanted to get that on the record this morning. Thank you, Mr. Chairman."

Chairman Ranzau said, "Thank you, Commissioner. Now, we are scheduled to have a reception for the new Chairman at what 10:30 a.m. Okay. We'll be there or be square, right? Anything else, Mr. Manager?"

Mr. Scholes said "That's it."

Chairman Ranzau said, "Seeing none, we are adjourned."
