Mr. Thomas Stolz, Interim County Manager, greeted the Commissioners and said, "Recommend you approve the lone consent agenda item on today's fire agenda. It is the appointment of the Interim Fire Chief.

"For the sake of the public, let me announce that it is, we're recommending Doug Williams as the, to serve as the Interim Fire Chief to take Chief Leake's place. Chief Williams began his career with Sedgwick County, the Fire District [No. 1] in 1988. He has served as a Division Chief of Operations for the last several years.

"He has a Master of Arts (M.A.) degree in Executive Fire Service Leadership from Grand Canyon University (GCU), Arizona and a Bachelor of Science (B.S.) degree from K-State (Kansas). He is also a graduate of the National Fire Academy (NFA).

"He has served as the Chief of the Eureka Volunteer Fire Department in Greenwood County Fire District [No.] 1, and he has also served as the Greenwood County Emergency Management. So effective when Chief Leake leaves us, will be our Interim Fire Chief. That's what our recommendation is. We will put a press announcement out after this meeting if the Commission approves this appointment."

Chairman Dennis said, "Thank you. Just in clarification, don't we have two consent items? Don't we have a resolution authorizing CFO (Chief Financial Officer) to transfer funds?"

Mr. Stolz said, "Okay, I only have one on my agenda. I'm sorry, sir."
