Mr. Joe Thomas, Director of Purchasing Department, greeted the Commissioners and said, "The meeting that was conducted on December 13th, we considered two items that we are bringing for your recommendation."

 STORM DEBRIS REMOVAL, TREE REMOVAL AND TREE TRIMMING SERVICES IN RESERVE A, DEER LAKES ESTATES ADDITION IN SEDGWICK COUNTY -- PUBLIC WORKS FUNDING -- PUBLIC WORKS

"This recommendation is to accept the proposal from Shawnee Mission Tree Services, [Inc.] dba Arbor Masters Tree Service at the rates listed for one (1) year with three (3) one (1) year options to renew.

"This recommendation is to accept the insurance premium renewals as listed for an estimated total cost of \$810,176.

Mr. Thomas said, "I'll be happy to try and answer any questions you may have, and I recommend its approval of these items."

Chairman Dennis said, "Thank you. Does we have questions for Mr. Thomas? I have a quick question on the tree removal. What's the total cost of that? It talks about cost per ton, but I didn't really pick up the total cost."

Mr. Jim Weber, Deputy Director, Public Works, greeted the Commissioners and said, "There's a \$250,000 allocated for debris removal. So in any given year, it's capped at the [\$]250,[000]."

Chairman Dennis said, "No, it's [\$]250,000. Is this public property that we're looking at?"

Mr. Weber, "It's a private reserve in a subdivision its, well you're going out to Spirit [AeroSystems]. So the creek that drains Spirit comes through 47th Street and it comes down into the back side of Oaklawn. So it's a major drainage way that happens to be in a private property. The topography down there is very difficult, so it's not really practical for the neighborhood to try to do anything with it. It wasn't practical at the time of the tornado for us to try to do anything with it, and so we're kind of catching up. "In the tornado, the situation is, if you can get the debris out to the public right-of-way, then we would haul it off, and we were reimbursed by FEMA (Federal Emergency Management Agency) and KDEM (Kansas Division of Emergency Management) for I don't know, 75 [percent] or 85 percent of the cost. This is something that wasn't practical to get to at the time.

"If they could've gotten it to the street, we would have hauled it off at the time, so it's delayed, funding is available in this debris removal thing out of the solid waste fee. So we are just trying to get it cleaned up before all that debris in there, downed trees and everything creates some kind of a problem that we don't want to manage later at a much higher cost."

Chairman Dennis said, "So can we go back to FEMA at this time now and say that this is tornado damage?"

Mr. Weber said, "No, no because they won't cover it on private property. It has to get to the public property and..."

Chairman Dennis said, "It will end up at public property when we haul it off."

Mr. Weber said, "Well the debris will, yes."

Chairman Dennis said, "Okay. It's a lot of money on a private piece of property. My only concern. Okay. Commissioner Howell."

Commissioner Howell said, "Thank you, Mr. Chairman. Just a comment on that. I think with it inside the cities, please correct me if I'm wrong, Mr. Weber, but inside cities, typically the cities will take responsibility for doing stream maintenance in their cities. If it gets done, we don't generally go inside the cities to do that, but any place

unincorporated, where we had been stream maintenance, really across the county in lots of places, in fact, I would say, the majority of places, it is private property. That's our typical thing we do, we coordinate with landowners to get access to those areas, and we remove deadwood and reslope banks and plant proper grasses, whatever, to reduce erosion.

"But a lot of this is done on private property across the entire county, which makes us different than other counties. I think Johnson County doesn't do this at all. But we have a stream maintenance crew that's been doing this for a very long time. This is the same type of work they've been doing. We just were able, we discovered through the discussion that the ice storm damage, those trees have been down, I don't remember when the ice storm was, it was a very long time ago, about 20 years ago now, but that was qualified for solid waste fee funding. So we increased the solid waste fee specifically for this purpose. This was a decision we made about a year and a half ago. So with that, I think we, I think it's, in fact, I think this is less than the estimate we had at the time."
