### CONSIDERATION OF A GRANT IN THE AMOUNT OF \$4,068,475 FOR THE COMMUNITY CORRECTIONS ADULT OFFENDER PROGRAMS IN SEDGWICK COUNTY.

**Grant Summary and Timeline:** Since 1983, the Kansas Department of Corrections (KDOC) has provided grant funding for Community Corrections Adult Offender Programs in Sedgwick County. Before grant awards are announced, KDOC requires the submission of the Community Corrections Comprehensive Plan for SFY15 (July 1, 2014 - June 30, 2015). The signed application is due to KDOC no later than May 1, 2014. The Corrections Advisory Board approved the application on April 10, 2014.

Source of other funding: \$405,000 in 33027-110 (CY15 request), \$225,000 in 33023-110 (CY15 request) and \$520,000 in client revenue. The Department of Corrections will also apply for local and federal Justice Assistance Grants (JAG), as done in the past. Once the final award is received from KDOC, adjustments will be made to the proposed budget.

**Budget Authority Adjustment:** Requests for additional authority for 2014 include \$5,000 in 33014-253, \$120,000 in 33015-253, and \$145,000 in 33020-253. Details are included in the attached budget forms.

**Expected measurable outcomes:** (1) To improve supervision success rate in SFY15 by at least 3 percent from the previous year; (2) To increase utilization of specialized interventions in an effort to improve offender success on probation; (3) Complete the LSI-R Short Version on presumptive prison cases.

**Alternatives:** If we do not submit a plan for approval, we will not continue to receive these KDOC funds. We are obligated under state law K.S.A. 75-5291 to provide community corrections supervision to offenders assigned by the District Court.

**Legal considerations:** The authority for this section is K.S.A. 19-101. A simple majority vote is required for approval.
