CONTRACT FOR A HOUSEHOLD HAZARDOUS WASTE REMOTE COLLECTION EVENT ON JUNE 27, 2015 FOR CITY OF DERBY, KANSAS.

RECOMMENDED ACTION: Approve the contract.

Background: Sedgwick County has a Household Hazardous Waste Facility at 801 Stillwell. Studies have shown that the majority of customers come from within a 6 mile radius. In order to provide safe household hazardous waste disposal to our community, the County offers 5 Remote Household Hazardous Waste collection events each year. These events allow residents to bring such items as paints, oils, cleaners, solvents, and other chemicals for proper disposal at a location near them. This agenda item addresses a contract for a remote household hazardous waste collection event at City of Derby, Kansas. City of Derby, Kansas approved this contract on May 4, 2015. The collection will take place on June 27, 2015 from 9:00 am until 1:00 pm at Derby High School Parking Lot, located at 920 N. Rock Rd. in Derby, Kansas.

Alternatives: Do not provide this community service.

Financial Considerations: HHW has provided 5 remote HHW collection events every year since 2005. Funding for these events comes from the Solid Waste Fee and expenditure authority is included in HHW Services fund center (43001-208, Contractual Services) as part of the 2015

Adopted Budget. The cost of \$14,000 is based on the average cost of HHW remote events in 2014. The actual cost will vary based on the number of participants and types of materials received. There are no revenues associated with this event.

Legal Considerations: The authority for this action is K.S.A. 65-3410. A simple majority vote is required.
