CONSIDERATION OF GRANT IN THE AMOUNT OF \$204,454 FOR OPERATIONAL COSTS OF THE JUVENILE DETENTION FACILITY.

Grant Summary and Timeline: The Kansas Department of Corrections (KDOC) announced the Juvenile Detention Facility Fund (JDFF) awards to eleven juvenile detention facilities operating in the State of Kansas, according to the percentage of licensed capacity at each facility. Kansas law requires that the JDFF be spent only on the following categories: construction, renovation/remodeling, operational costs, equipment/supplies. The SFY16 award is \$13,998 more than the SFY15 award due to a reduced detention center capacity in the State of Kansas.
