Fire District 1 is the recipient of donations from the Briggs Memorial Fund. To date, the fund has received \$1,920. The memorial fund will help to underwrite expenses associated with Sedgwick County Fire District 1.

Financial Considerations: The total amount of the donation, \$1,920.00, will be deposited in cost center 14001-242. If approved, budget authority of an equal amount may be established in the fund center for the 2018 budget year. If any portion of the donation is unspent at the end of 2018, budget authority equaling the remaining amount may be established for the 2019 budget year.

Legal Considerations: The authority for this action is K.S.A. 19-3601a.
